17" Top	484	Women's and Juniors: Dresses, Blouses, Woven Tops, Robes, Sleepwear, Jackets, 1-pc Swimwear; Men's and Young Men's: Tops, Robes, Sleepwear, Jackets
12" Top	498	Children's: Dresses, Blouses, Woven Tops, Robes, Sleepwear, Jackets, 1-pc Swimwear, Lightweight Outerwear
15" Top	485	Children's and Pre-Teens: To be used when the 12" Top Hanger is too Small
10" Bottom	6010	Women's and Juniors: Pants, Skirts, Shorts, 2-pc Swimwear; Men's and Young Men's: Pants and shorts Use 14" Bottom Hanger – Style 6014 – if 12" hanger is too small For Heavy Weight Bottoms May Use 10" – Style 1200 or 12" – Style 1203

- Use a combination of top and bottom hangers for all 2-pc Men's, Women's, and Children's (over Girls 6x and Boys 7) coordinates/sets.
- Use white foam covers on top hangers if garment slippage is a problem.
- Use bottom hangers with padding if needed.

- Infants, Toddlers, Children's (to Girls 6x and Boys 7) Coordinates or Sets:** Use white plastic, molded hook, frame hanger in common use today or as per current agreement.
- Infants, Toddlers, Children's (to Girls 6x and Boys 7) Separates:** Use white plastic, molded hook hanger in common use today or as per current agreement.
- Intimate Apparel:** Use clear plastic, molded hook bra & panty hanger in common use today or as per current agreement.
- Men's Sports Coats and Suits:** Use wishbone style mahogany colored wood or black plastic hanger with pant bar, if needed, or as per current agreement.
- Men's, Women's, and Children's Sweaters and Knit Tops:** Do not hang. Instead, place hangers in carton with the merchandise.

NOTE: Belk fully expects its Trading Partners that provide hanging-type merchandise to ship their goods on VICS approved standard floor ready hangers. The choice of hanger resource is at the discretion of the Trading Partner and Belk will consider merchandise that arrives on VICS compliant hangers to be in compliance with the Belk Hanger Program as described above. Use of a hanger that does not meet VICS standards may result in an expense offset charge.
